**A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY AT BARANGAY TALABA 2, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF TWO MILLION TWO HUNDRED THOUSAND PESOS (PHP 2,200,000.00) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.**

**WHEREAS**, in the wee hours of 03 June 2025, a fire broke out at a house in Sitio Baywatch, Barangay Talaba 2, City of Bacor, Cavite, that rapidly spread to adjacent residential units which were mostly made from light materials.

**WHEREAS**, the City of Bacor Disaster Risk Reduction and Management Council (CBDRMC) passed a Resolution No. 04 Series of 2025 dated June 3, 2025, requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Talaba 2, City of Bacor, Cavite and authorizing the release of **Two Million Two Hundred Thousand Pesos (Php 2,200,000.00)** from the City Disaster Risk Reduction and Management Fund.

**WHEREAS**, a copy of the said CBDRMC Resolution No. 04, Series of 2025 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

**WHEREAS**, during the said hybrid session, majority of the members of the Sangguniang Panlungsod voted in favor of approving the aforementioned request of the CDRRMC.

**NOW THEREFORE**, upon the motion of Hon. Alejandro F. Gutierrez, unanimously seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in hybrid session assembled to declare the existence of a state of calamity in Barangay Talaba 2, City of Bacoor, Cavite and authorizing the release of **Two Million Two Hundred Thousand Pesos (Php 2,200,000.00)** from the City Disaster Risk Reduction and Management Fund for financial assistance, relief goods, and other incidental expenses in relation to the relief and rehabilitation operations.

**RESOLVED LASTLY**, to furnish the Office of the City Mayor, the CBDRRMC, and other government agencies concerned with copies of this resolution.
