CITY RESOLUTION NO. 2025-729 Series of 2025

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY AT BARANGAY TALABA 3, CITY OF BACOOR, CAVITE AND AUTHORIZING THE RELEASE OF FIVE MILLION SIX HUNDRED THOUSAND PESOS (PHP 5,600,000.00) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER **EXPENSES** RELATED TO RELIEF AND INCIDENTAL REHABILITATION OPERATIONS.

WHEREAS, in the evening of 07 June 2025, a fire broke out at a house in Zone 6, Barangay Talaba 3, City of Bacoor, Cavite, that rapidly spread to adjacent residential units which were mostly made from light materials.

WHEREAS, the City of Bacoor Disaster Risk Reduction Management Council (CBDRRMC) passed and a Resolution No. 05, Series of 2025 dated June 8, 2025, requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Talaba 3, City of Bacoor, Cavite and authorizing the release of Five Million Six Hundred Thousand Pesos (Php 5,600,000.00) from the City Disaster Risk Reduction and Management Fund.

WHEREAS, a copy of the said CBDRRMC Resolution No. 05, Series of 2025 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

WHEREAS, due to the exigencies of public service, the necessity of immediate action on the request of the CDRRMC, and the desperate situation of those impacted
