### CITY RESOLUTION NO. 2025-732 Series of 2025

RESOLUTION EXPRESSING THE INTENTION DETERMINATION OF THE CITY GOVERNMENT OF THE CITY OF BACOOR, CAVITE TO EMPLOY ALL LAWFUL MEANS AT ITS DISPOSAL TO DEFEND THE RIGHT TO RECEIVE FREE, HIGH QUALITY EDUCATION OF THE STUDENTS ENROLLED AT THE BACOOR CITY CAMPUS OF THE CAVITE STATE UNIVERSITY BEFORE ANY COURT OF LAW OR TRIBUNAL INCLUDING THE OPTION OF ACQUIRING THE PARCEL OF LAND ON WHICH THE SAID LEARNING INSTITUTION IS SITUATED PURSUANT TO THE EXERCISE OF THE POWER OF EMINENT DOMAIN.

WHEREAS, Republic Act No. 10391 (the "Universal Access to Quality Tertiary Education Act") was enacted for the purpose of providing free, quality tertiary education to all Filipino students enrolled at state universities and colleges such as the Cavite State University.

WHEREAS, the Cavite State University (CSU) — with the assistance of the Bacoor City Government — established a campus along Niog Road in Barangay Niog, City of Bacoor, Cavite where college students may receive free, quality education.

WHEREAS, it has come to the knowledge of the students of the Bacoor City Campus of the CSU that there are conflicting claims over the land on which the said learning institution is situated which might result in the disruption of their studies and in the deprivation of their right to free, quality education under RA 10391.

WHEREAS, Republic Act No. 10160 (the "Charter of the City of Bacoor, Cavite") and Republic Act No. 7160 (the "Local Government Code of 1991") vested City Government with the duty to promote the public welfare and to exercise the power of eminent domain.

WHEREAS, the Student Council of the CSU-Bacoor City Campus requested the City Government through Mayor Strike Revilla to come to their succor and undertake measures that will ensure the untrammeled exercise of their right to free, quality tertiary education under RA 10391 in the face of possible legal issues related to competing claims over the said parcel of land.

WHEREAS, the City Mayor informed the Sangguniang Panlungsod about the legitimate concerns of the students of the CSU-Bacoor City Campus and requested the esteemed members of the said august body to pass a resolution that will put the minds of the students and administrators of the said learning institution to rest by expressing the unqualified determination of the City Government to utilize all lawful means at its disposal — including the exercise of its power of eminent domain and its prerogative to provide legal assistance to the students and administrators of the CSU — to safeguard the right of the said students to free, quality tertiary education.

**WHEREAS**, the members of the Sangguniang Panlungsod deliberated on the request of the City Mayor and unanimously agreed to grant the same.

NOW THEREFORE, upon the unanimous motion of all its members, BE IT RESOLVED as it is hereby RESOLVED by the 5th Sangguniang Panlungsod in special session duly assembled to express the unqualified intent and strong determination of the City Government of the City of Bacoor, Cavite to employ all lawful means at its disposal to defend the right to receive free, high quality tertiary education of the students enrolled at the Bacoor City campus of the Cavite State University before any court of law or tribunal including the option of acquiring the parcel of land on which the said learning


