WHEREAS, the Sangguniang Panlalawigan enacted on 2 December 2024 Provincial Ordinance No. 470-2024 entitled: "AN ORDINANCE ESTABLISHING A COMPREHENSIVE YOUTH CODE IN THE PROVINCE OF CAVITE, APPROPRIATING FUNDS, AND FOR OTHER PURPOSES".

WHEREAS, Provincial Ordinance No. 470-2024 (also known as the "Comprehensive Youth Code of the Province of Cavite") aims to promote and protect the physical, moral, spiritual, intellectual and social well-being of the Caviteño youth, inculcating in them patriotism and nationalism and encouraging their involvement in public and civic affairs".

WHEREAS, the Sangguniang Kabataan Federation President of the City of Bacoor, Hon. Palm Angel S. Buncio moved for the adoption of Provincial Ordinance No. 470-2024 through a Resolution in order to formalize its implementation in the City and ensure that the laudable objectives behind its passage may be given effect.

WHEREAS, after deliberating on the said motion, the Sanggunian unanimously voted in favor of adopting Provincial Ordinance No. 470-2024.
