WHEREAS, the City Government of the City of Bacoor, Cavite is the only local government in the Province of Cavite that is ISO 9001: 2015 certified and promotes the delivery of the highest quality of public service to attain customer satisfaction.

WHEREAS, the Sangguniang Panlungsod received various complaints from taxpayers about the refusal of the Office of the City Treasurer to accept real property tax payments from taxpayers who has not declared various improvements on their parcels of land for real property taxation purposes pursuant to a policy proposed by the former Acting City Assessor of the City Government, Engr. Allan Quinatadcan.

WHEREAS, the said policy is still being reviewed by the Sangguniang Panlungsod and has not yet been adopted as the official policy of the City Government.


