**A RESOLUTION INTERPOSING THE VEHEMENT OBJECTION OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE TO THE PROPOSED PARAÑAQUE SPILLWAY PROJECT.**

**WHEREAS**, the Parañaque Spillway Project is a flood-control project being proposed by the Department of Public Works and Highways (DPWH) based on a study conducted by the Japan International Cooperation Agency (JICA) intended to solve flooding in the areas surrounding Laguna Lake and described in the official website of the said agency as an "open channel and tunnel with the inlet at the land side in Buli (south side of Sucat) and with the outlet at the Zapote River mouth with a maximum outflow discharge of 240 cubic meter per second".

**WHEREAS**, the DPWH also described the Parañaque Spillway Project in its official website as a "deep tunnel technology with an inner diameter of 13 meters having a tunnel depth that is ranging from 50 to 77 meters from the existing ground with a total tunnel length of 10.50 km".

**WHEREAS**, the DPWH further described the said project as an underground structure that will connect Laguna Lake to Manila Bay and will avoid spilling of lake water into low-lying communities as it will traverse 50 meters below underground the cities of Muntinlupa, Parañaque, Las Piñas, and Bacoor City in Cavite.

**WHEREAS**, the proposed project was reviewed by the Committee on Public Works and Highways of the Sangguniang Panlungsod pursuant to its oversight functions and the right of its members as elected representatives of the City of Bacoor to uphold the right of Bacooreños to reside in a city that is safe and environmentally friendly.

**WHEREAS**, the Committee on Public Works and Highways of the Sangguniang Panlungsod called a hearing on the said project attended by the heads of the various
