

CITY RESOLUTION NO. 2025-745 Series of 2025

A RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FILED AGAINST ELECTIVE BARANGAY OFFICIALS BARANGAY P.F. ESPIRITU 3, CITY OF BACOOR, CAVITE DUE TO LACK OF LEGAL AND FACTUAL BASIS.

WHEREAS, an administrative complaint was filed by an anonymous complainant through the Civil Service Commission against the various elective officials of Barangay P.F. Espiritu 3 for allegedly mishandling a sexual harassment complaint regarding unsolicited sexual advances allegedly made by an unnamed "abuser" against the said complainant that allegedly took place at a spa situated in the said barangay on 27 May 2025 between 4:15 a.m. to 5:40 a.m.

WHEREAS, the said complaint was sent by the CSC to the Office of the City Administrator and was endorsed to the Sangguniang Panlungsod on 10 June 2025.

WHEREAS, on 16 June 2025, the said complaint was included in the Order of Business of the Sangguniang Panlungsod and was referred after First Reading to the Committee on Ethics, Appointments and Government Reorganization (the "Committee") which conducted a series of hearings on the matter.


WHEREAS, the said hearings were attended by the various elective officials of Barangay P.F. Espiritu 3 and the said Committee was given unfettered access to all of the relevant official records of the said barangay. Unfortunately, the Committee was unable to identify or locate the anonymous complainant mentioned above despite exerting its best efforts which included visiting the purported address of the complainant which was found to be inexistent and contacting the cellphone number provided by him several times on various dates only to discover that it was already out of service at the time when the hearings were being conducted.

WHEREAS, after the said hearings and based on the evidence its members were able to gather, the Committee was able to

determine that the said complaint lacked factual and legal basis due to the following reasons:

- (1) The barangay officials that had a direct hand in the said incident observed the proper procedure in protecting the complainant from further abuse or harassment from his purported abuser by placing them in separate rooms while each was being questioned;
- (2) The barangay officials involved entered the incident in the blotter of the barangay and made the appropriate reports in relation thereto in anticipation of the filing of the appropriate criminal complaint against the purported abuser of the complainant; and
- (3) The respondent barangay officials had every intention to initiate the filing of the appropriate criminal complaint in coordination with the police after they have gathered more evidence from the complainant but were not able to do so because the latter did not return to Barangay P.F. Espiritu again and several diligent efforts to locate or contact him done by the respondents all failed.

WHEREAS, due to all the foregoing reasons, the Committee recommended that the said complaint be dismissed for lack of factual and legal basis.

NOW THEREFORE, upon motion of Hon. Miguel N. Bautista, unanimously seconded by the rest of the City Council, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled to DISMISS the complaint filed against the elective officials of Barangay P.F. Espiritu 3, City of Bacoor, Cavite due to utter lack of legal and factual basis.

RESOLVED FURTHER, to furnish the CSC, the Office of the City Mayor, Barangay P.F. Espiritu 3 and other government agencies concerned with copies of this Resolution.
