A RESOLUTION ADOPTING PROVINCIAL RESOLUTION NO. 3882-2025 DECLARING THE EXISTENCE OF A STATE OF CALAMITY OVER THE ENTIRE PROVINCE OF CAVITE DUE TO TYPHOON CRISING AND AUTHORIZING THE RELEASE OF TEN MILLION PESOS (PHP 10,000,000.00) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL RELIEF AND REHABILITATION EXPENSES RELATED TO OPERATIONS.


WHEREAS, Provincial Resolution No. 3882-2025 was approved on July 22, 2025 declaring the existence of state of calamity over the entire Province of Cavite due to the widespread adverse impact of the Southwest Monsson enhanced by Typhoon Crising on the whole Province including the City of Bacoor.

WHEREAS, the declaration of a state of calamity enables the local government to access emergency funds swiftly and implement relief operations to aid 39,834 families residing in 43 of the 47 barangays in the City of Bacoor that were displaced due to knee-high floods brought on by continuous heavy rains.

WHEREAS, the Bacoor City Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 06, Series of 2025 dated July 23, 2025, requesting the Sangguniang Panlungsod to authorize the release of Ten Million Pesos (Php 10,000,000.00) from the City Disaster Risk Reduction and Management Fund to augment the need for food, emergency supplies and other related relief operations.
