

WHEREAS, on 10 April 2025, the said complaint was endorsed by the Office of the City Legal Services to the Sangguniang Panlungsod for appropriate action.


WHEREAS, the said matter was referred to the Committee on Ethics, Appointments and Government Re-Organization and Committee on Barangay Affairs for investigation:
