**CITY RESOLUTION NO. 2025-766**

**SERIES OF 2025**

**A RESOLUTION RESPECTFULLY REQUESTING AND AUTHORIZING SAN MIGUEL CORPORATION AND MR. RAMON S. ANG TO ASSIST THE CITY GOVERNMENT OF THE CITY OF BACOR, CAVITE IN DREDGING AND DESILTING MOLINO DAM, PRINZA DAM, ZAPOTE RIVER AND IMUS RIVER IN ORDER TO PREVENT FLOODING IN VARIOUS BARANGAYS OF BACOR AND NEARBY AREAS.**

**WHEREAS**, the torrential rains brought by typhoons Crising, Dante and Emong resulted in flooding in 43 of the 47 barangays of the City of Bacoor.

**WHEREAS**, over 39,000 families residing in the City of Bacoor evacuated when the floods were at its peak.

**WHEREAS**, the City Government of the City of Bacoor spent P10,000,000.00 out of its Local Disaster Risk Reduction and Disaster Management Fund to finance relief operations in support of the Bacooreños who were affected by the said deluge.

**WHEREAS**, part of the reason behind the occurrence of the said floods is the greatly reduced capacity of Molino Dam, Prinza Dam, Zapote River and Imus River — all located in the City of Bacoor — to absorb flood waters coming from Laguna, Muntinlupa and other localities near Bacoor.

**WHEREAS**, the absorptive capacity of the said waterways was significantly reduced by heavy siltation brought on by improper waste disposal practices.

**WHEREAS**, the City Government does not have the funds and the equipment to dredge and desilt the said bodies of water.
