CITY RESOLUTION NO. 2025-769

A RESOLUTION AUTHORIZING THE CITY MAYOR TO FILE THE APPROPRIATE LEGAL ACTION AGAINST VARIOUS PUBLIC UTILITY COMPANIES DOING BUSINESS IN THE CITY OF BACOR, CAVITE FOR ENDANGERING PUBLIC SAFETY AND CAUSING INCONVENIENCE THROUGH IMPROPER PLACEMENT OF UTILITY POLES ON SIDEWALKS AND DRAINAGE SYSTEMS, AND FAILURE TO REMOVE ABANDONED WIRES AND CABLES.

WHEREAS, Section 16 of the Local Government Code mandates local government units to exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Anti-Dangling Wire Ordinance of the City of Bacoor was enacted in 2013 primarily to regulate the installation and maintenance of electric poles and wires, cables for television, and telephone/telecommunication poles, towers and cables/wires distribution lines of various public utilities within the City of Bacoor;

WHEREAS, under said ordinance, the City Engineering Office is primarily tasked to ensure that installation of poles by the public utility companies conforms with the established standards and that prior approval of City Engineering Office has been secured;

WHEREAS, Section 458 (5) of the Local Government Code authorizes the Sangguniang Panlungsod to enact ordinance which shall ensure the efficient and effective delivery of the basic services and facilities including regulating of traffic on all streets, authorizing the removal or encroachment and illegal constructions in public places; regulating the construction, repair and maintenance of

public drains, and similar structures; regulating the placement of poles, adopting measure to ensure public safety against open canals, live wires, and other similar hazards to life and property; regulating the installation of electric wires, conduits, and other apparatus, with provision for their correction, condemnation or removal if found to be dangerous, defective or otherwise hazardous to the welfare of the inhabitants;

WHEREAS, despite existing regulatory policies, certain public utility companies continue to violate regulations in installing poles in areas designated for drainages drainage/sidewalk, endangering the pedestrians, obstructing public access, and aggravating the flooding especially in low-lying communities;

WHEREAS, the City Engineering Office conducted a series of road inspections and confirmed that some public utility poles were improperly constructed on sidewalk and drainage easements, and that unused utility wires were left dangling from poles along major roads in City of Bacoor in violation of applicable city ordinance and national laws;

WHEREAS, on 17 July 2025, the Office of the City Mayor requested the Sangguniang Panlungsod to pass a resolution authorizing the filing of the appropriate legal action against non-compliant public utility company/ies for unlawful pole installations, and maintenance;

WHEREAS, the Sangguniang Panlungsod deliberated upon the said request and unanimously decided to pass the instant Resolution;

NOW THEREFORE, upon motion of Honorable Reynaldo D. Palabrica, unanimously seconded by the rest of the city council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite, to authorize the City Mayor, or his duly designated representative, to initiate and file appropriate legal action, after exhaustion of all administrative remedies, against public utility company/ies for violation of the Anti-Dangling Wire Ordinance and non-compliance with relevant national laws or issuances and regulations governing the installation and maintenance of public utility poles.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the City Engineering Office, the Office of the City Legal Service and other government agencies concerned with copies of this Resolution.
