

CITY RESOLUTION NO. 2025-777 Series of 2025

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON, STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF CAVITE (PGC), REPRESENTED BY HON. FRANCISCO GABRIEL D. REMULLA ON BEHALF OF THE CITY GOVERNMENT OF BACOOR FOR THE GRANT OF FINANCIAL ASSISTANCE TO THE CITY GOVERNMENT OF BACOOR AMOUNTING TO ONE MILLION PESOS (PHP1,000,000.00).

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides that every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, on 05 August 2025, the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Honorable Strike B. Revilla, to sign a Memorandum of Agreement (MOA) with the Provincial Government of Cavite (PGC) represented By Hon. Francisco Gabriel D. Remulla on behalf of the City Government of Bacoor.

WHEREAS, the City Government of Cavite will be holding the City of Bacoor's 354th Founding Anniversary (Bakood Festival 2025);

WHEREAS, the City Government of Bacoor is in need of funds for the implementation of the said activity;


WHEREAS, the Provincial Government of Cavite has the means to financially support the said activity;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (the "Agreement"), is made and entered into this ____ day of ____ 2025 (the "Effective Date") in Trece Martires City, Province of Cavite, by and between:

The PROVINCIAL GOVERNMENT OF CAVITE, a political subdivision of the Republic of the Philippines, with official address at the Provincial Capitol Compound, Trece Martires City, Province of Cavite, represented herein by its Governor, FRANCISCO GABRIEL D. REMULLA, duly authorized for the purpose, hereinafter referred to as the "FIRST_PARTY".

and

The CITY GOVERNMENT OF BACOOR, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with its principal office address at Bacoor Government Center, Bacoor Boulevard Barangay Bayanan, City of Bacoor, Province of Cavite, represented herein by its City Mayor, STRIKE B. REVILLA, duly authorized for the purpose, hereinafter referred to as the "SECONO PARTY"

The term "Party" shall mean the FIRST PARTY or the SECOND PARTY, if applicable, while the term "Parties" shall mean the FIRST PARTY and SECOND PARTY collectively

WITNESSETH:

WHEREAS, Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991; specifically provides that the local government units (LGU) shall endeavor to be self-reliant and continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, LGUs shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities essential to the promotion of the general welfare;

WHEREAS, these powers include the implementation of priority programs and projects for the provision of the basic services and facilities as embodied under the Local Government Code of 1991;

WHEREAS, the SECOND PARTY is in need of funds for the implementation of their priority programs and projects/trainings;

WHEREAS, the SECOND PARTY has the administrative and technical means to fully implement this program in close coordination with the FIRST PARTY;

WHEREAS, the Sangguniang Panlalawigan of Cavite passed Resolution No.
______, Series of 2025, authorizing the Governor, HON. FRANCISCO GABRIEL D.
REMULLA to enter into Memoranda of Agreement with LGUs in the Province of Cavite for the grant of financial assistance to the latter;

WHEREAS, the Sangguniang Panlungsod of Bacoor, Cavite, passed City Resolution No. _____, Series 2025, authorizing its City Mayor, HON. STRIKE B. REVILLA, to enter into a Memorandum of Agreement with the Provincial Government of Cavite for the grant of financial assistance to the former and to comply with the fund requirements;

NOW THEREFORE, for and in consideration of the above premises and the lerms and conditions hereunder enumerated, the PARTIES to this Agreement hereby agree as follows:

- 1. The PARTIES shall at all times take the necessary action to cooperate with each other and to perform their respective duties and responsibilities in order to achieve the objectives of this agreement;
- The FIRST PARTY shall grant Thancial assistance to the SECOND PARTY to assist the latter in the delivery of basic services and for the implementation of its priority programs and projects;
- The SECOND PARTY, shall—exclusively utilize the fund for the implementation of its priority programs and projects in accordance with existing government budgeting procurement, accounting, and auditing rules and regulations;
- 4. The SECOND PARTY shall keep track and make an accounting of its disbursements of the financial assistance granted to it by the FIRST PARTY for the former's priority projects/trainings:

The SECOND PARTY shall submit a written summary and report thereof to the FIRST PARTY fifteen (15) days after the utilization of the funds appropriated. The same shall include the certified true copies of the supporting documents for the implementation of the said priority programs and projects and such other information reasonably necessary to the purpose;

- The SECOND PARTY shall submit the approved project expenditures
 or estimated expenses indicating the project objective and expected
 output, in compliance with COA Circular No. 2012-001;
- The SECOND PARTY shall refund/return unused funds to the Provincial Treasurer's Office:
- 8. For financial assistance relating to electrification projects, the **SECOND** PARTY shall:
 - 8.1 Inform MERALCO or any other electric company concerned that funds for the project were obtained through financial assistance from the FIRST PARTY;

- 8.2 Request that MERALCO or any other electric company concerned that the refund from the project or any part thereof equivalent/in proportion to the amount of financial assistance granted be payable to the FIRST PARTY; and
- 8.3 If a refund is made payable to the SECOND PARTY, to turn over/remit to the FIRST PARTY the said refund or any part thereof equivalent/in proportion to the amount of financial assistance granted.
- The FIRST PARTY shall not allow subsequent release of funds to the SECOND PARTY with unliquidated balances; and
- 10. All payments and releases by the SECONO PARTY under the priority programs and projects of the FIRST PARTY shall be made in accordance with existing government accounting and auditing rules and regulations.
