A RESOLUTION ADOPTING THE REGIONAL DEVELOPMENT COUNCIL RESOLUTION NO. IV-A-37-2025 REGARDING THE TUTOK KAINAN DIETARY SUPPLEMENTATION PROGRAM OF THE NATIONAL NUTRITION COUNCIL.

WHEREAS, on 5 June 2025, the Regional Development Council (RDC) passed a resolution mandating all member local government units to implement a targeted dietary supplemental feeding program for children aged 6-23 months for 180 days.

WHEREAS, on 06 August 2025, the City Mayor, Hon. Strike B. Revilla, formally requested the Sangguniang Panlungsod to pass a resolution adopting RDC Resolution No. IV-A-37-2025 regarding the Tutok Kainan Dietary Supplementation Program of the National Nutrition Council.

WHEREAS, in line with the directives of RDC, the city recognizes the need to strengthen its efforts in implementing a feeding program for children and pregnant mothers, by providing additional funds or partnering with stakeholders for the successful implementation of the program.

WHEREAS, the said matter was referred to the Committee on Social Services as lead committee, Committee on Health and Sanitation and to the Committee on Women, Children and Family Relations for committee hearing;

WHEREAS, on 27 August 2025, the said committees conducted a hearing and decided to recommend the adoption of RDC Resolution No. IV-A-37-2025 regarding the Tutok Kainan Dietary Supplementation Program of the National Nutrition Council for approval.
