A RESOLUTION AUTHORIZING THE CITY MAYOR, HON, STRIKE B. REVILLA, TO SIGN A DEED OF DONATION AND ACCEPTANCE ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (DENR-PENRO) PERTAINING TO THE DONATION OF A TRASH COLLECTOR BOAT NO.1 AMOUNTING TO EIGHTY THOUSAND PESOS (PHP80,000.00).

WHEREAS, on 22 August 2025, the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting that a resolution be passed authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Deed of Donation and Acceptance between the City Government of Bacoor and the Department of Environment and Natural Resources, Provincial Environment and Natural Resources Office (DENR-PENRO) regarding the donation of a Trash Collector Boat No. 1 to the city government.

WHEREAS, the DENR intends to donate a trash collector boat worth Eighty Thousand Pesos (PhP80,000.00) to the city government as a part of its mandate to enforce and implement the Operational Plan for the Manila Bay Coastal Strategy (OPMBCS), particularly described as follows:

Revilla, to sign a Deed of Donation and Acceptance on behalf of the City Government of Bacoor with the Department of Environment and Natural Resources, Provincial Environment and Natural Resources Office (DENR-PENRO) pertaining to the donation of a Trash Collector Boat No.1 amounting to Eighty Thousand Pesos (Php80,000.00).



The DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, PROVINCIAL ENVIRONMENT AND NATURAL (DENR-PENRO) RESOURCES OFFICE Cavite, a government agency organized and existing under and by virtue of the laws of the Republic of the Philippines, herein represented in this Act by JANUEL R. PERAS in his capacity. as PENR Officer of DENR-PENRO Cavite, with office address at DENR-PENRO Cavite Building. Barangay Gregorio, Trece Martires City, Cavite, hereinafter referred to as the "DONOR"

and

The CITY GOVERNMENT OF BACOOR, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with its principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavile, represented herein by its City Mayor, Hori. STRIKE B. REVILLA, pursuant to his authority conferred and embodied in City Resolution. No. _______, Series of 2025, approved by the City Council of Bacoor dated ______, and hereinafter referred to as the "DONEE"

WITNESSETH:

WHEREAS, the DONOR is the absolute owner of a Trash Collector Boat No. 1 worth EIGHTY THOUSAND PESOS (PHP 80,000.00), particularly described as follows:

WHEREAS, the DONOR procured the aforementioned Trash Collector Boat. No. 1 purposely to enforce and implement the Operational Plan for the Manila Bay Coastal Strategy (OPMBCS) in compliance with the February 15, 2011, Resolution of the Supreme Court pursuant to the Continuing Mandamus it issued through the December 18, 2006 Decision in G.R. Nos. 171947-48;

WHEREAS, the DONOR recognizes the contributory effort of the DONEE in Solid Waste Management along Manila Bay;

WHEREAS, the DONOR hereby voluntarity and freely gives by way of donation unto the said DONEE, or the DONOR's act of liberality and generosity, the aforementioned Donated Property;

NOW, THEREFORE, the DONOR hereby voluntarily and freely gives, transfers, and conveys by way of donation unto said DONEE all of its right, title, and interest over the above Donated Property together with all the improvements thereon, free from all liens and endumbrances, solitates the said Trash Collector Boat No. 1 unto the DONEE, subject to the following terms and conditions:

That the DONEE shall sign the Invoice Receipt to Property (IRP) and Acknowledgement Receipt for Equipment (ARE) and assume full responsibilities and accountabilities in the operation; repair, and maintenance of the Donated Property;

That the DONES shall provide adequate funds and qualified manpower for the continuous operation and maintenance of the Trash Collector Boat;

That the DONEE shall operate and maintain the Trash Collector Boat in accordance with safety standards, taking into account the boat's capabilities and limitations:

That the DONEE shall conduct at least twice a week collection of garbage/trash or as the need arises and submit a monthly report to the DENR Manila Bay Coordinating Office – Site Management Office, Region 4A (SMO-Region 4A) thru the PENRO-Cavite on the accomplishment indicating the total volume as well as the corresponding composition (biodegradable, recyclable, residuals, special) of garbage/trash/litter per collection and other related activities, and regular maintenance service records of the Trash Collector Boat;

That the DONEE shall ensure that collected waste shall be disposed of in accordance with the Republic Act (R.A.) No. 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000";

That the DONEE shall keep the DENR free from any and all liabilities arising from its operations of the Trash Collector Boat;

That the DONEE shall utilize the Trash Collector Boat solely and exclusively for the collection of floating garbage within its area of jurisdiction, specifically rivers in Baccor City;

That the said donation is subject to Article 764 of the Civil Code of the Philippines, which reads:

"Art. 764 The donation shall be revoked at the instance of the donor when the donee fails to comply with any of the conditions that the former imposed upon the latter.

In this case, the property donated shall be returned to the donor $x \times x$."

That the DONOR affirms that the aforementioned donation to the DONEE is not made with the intent to defraud its creditors, and it has sufficient funds and properties;

That the DONEE hereby accepts and receives this donation made in its favor by the DONOR and hereby expresses its appreciation and gratefulness for the kindness and generosity of the DONOR in recognizing the abovementioned goods.
