

## CITY RESOLUTION NO. 2025-795 Series of 2025

A RESOLUTION AMENDING THE INTERNAL RULES OF PROCEDURE RECORD MANAGEMENT MANUAL AND THE OF THE SANGGUNIANG PANLUNGSOD AUTHORIZING THE INCLUSION OF MESSAGES IN GROUP MESSAGING APPLICATIONS LIKE VIBER AND MESSENGER AS PART OF THE OFFICIAL RECORDS OF THE CITY COUNCIL.

WHEREAS. Sangguniang the Panlungsod empowered by Section 50 of Republic Act No. 7160 (the "Local Government Code of 1991") to promulgate its own rules of procedure which includes the manner by which it shall safeguard and manage its records.

WHEREAS, though there is no specific law which consider messages made in messaging applications such as Viber or Messenger as public records, the Supreme Court has held that such content, even if from private accounts, can be used as evidence in court if obtained legally.

WHEREAS, Section 33 City Resolution 2025-733 (otherwise known as the "2025-2028 Internal Rules of Procedure of the Sangguniang Panlungsod of the City of Bacoor, Cavite") which was approved by the 6th Sangguniang Panlungsod on 30 June 2025 provides that:

"SECTION 33. COMMENCEMENT OF REGULAR SESSIONS.: HYBRID SESSIONS. - Unless majority of the members of the Sanggunian provides otherwise by way of Resolution, the regular session shall commence promptly at 10:30 in the morning every Monday at the Session Hall of the Sangguniang Panlungsod,

WHEREAS. due to technical difficulties encountered by members of the Sangguniang Panlungsod with existing videoconferencing apps such as Zoom and the need to pay for annual subscriptions to use the same, all of the members of the 6th Sangguniang Panlungsod has decided to conduct their hybrid sessions through a group chat using the Viber messaging application.

WHEREAS, the use of the said messaging application during hybrid sessions of the Sangguniang Panlungsod especially whenever the City of Bacoor is under a state of calamity has proven instrumental in the speedy, efficient, and cost-effective performance of the official duties of the City Council.

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod has decided to revise Section 33 of the 2025-2028 Internal Rules of Procedure of the Sangguniang Panlungsod so that it shall now read as follows:




