

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON, STRIKE B. REVILLA TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF THE CITY GOVERNMENT OF BACOOR WITH INCORPORATED PERTAINING TO THE PROVISION OF MEDICAL SERVICES, DIAGNOSTICS, AND LABORATORY TESTING AS PART OF THE PHILHEALTH KONSULTA PACKAGE.

WHEREAS, on 31 July 2025, the Sangguniang Panlungsod received an endorsement letter from the Office of the City Mayor requesting the City Council to pass a resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement (MOA) on behalf of the City Government of Bacoor with 1Life Incorporated pertaining to the provision of medical services, diagnostics, and laboratory testing as part of the Philhealth Konsulta Package.

WHEREAS, Section 16 of Republic Act No. 7160 (the "Local Government Code of 1991") empowered local governments to ensure and support within their respective territorial jurisdictions, the promotion of public health and the general welfare among other things;

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth) is committed in expanding the primary care benefit to cover all Filipinos and taking an initial step towards adopting a comprehensive approach to delivering primary care through the development of the Philhealth Konsulta Package;

WHEREAS, the City Government of Bacoor desires to extend its medical services, diagnostics, and laboratory testing to the city residents in availing PhilHealth's Konsulta Package through the 1Life Incorporated as an accredited Konsulta Partner.

WHEREAS, a draft Memorandum of Agreement was


