WHEREAS, a letter dated 29 August 2025 from the Office of the City Mayor was received by the Sangauniana Panlungsod, requesting the City Council to pass a resolution granting authority to City Mayor, Hon. Strike B. Revilla to sign Memorandum of Agreement between the City Government and Davies Paints Philippines, Inc. implementation of the Davie's project of providing traffic and directional signage to the City of Bacoor specifically on the roads covered by Solidarity Route.

WHEREAS, on 1 September 2025, the abovementioned matter was referred to the Committee on Rules, Privileges, Laws and Ordinances:
