A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH DAVIES PAINTS PHILIPPINES, INC.

WHEREAS, a letter dated 29 August 2025 from the Office of the City Mayor was received by the Sangguniang Panlungsod, requesting the City Council to pass a resolution granting authority to City Mayor, Hon. Strike B. Revilla to sign a Memorandum of Agreement between the City Government and Davies Paints Philippines, Inc. for the implementation of the Davie's project of providing traffic and directional signage to the City of Bacoor specifically on the roads covered by Solidarity Route.

WHEREAS, on 1 September 2025, the abovementioned matter was referred to the Committee on Rules, Privileges, Laws and Ordinances;

WHEREAS, no cost will be charged on the part of the City Government of Bacoor with regard to the implementation of the said project.

WHEREAS, the Sangguniang Panlungsod deliberated on the said request and found it to be advantageous to the City of Bacoor;

WHEREAS, under the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign on its behalf all contracts upon the authority of the Sangguniang Panlungsod. Moreover, no contract may be entered into by the local chief executive without the Sangguniang Panlungsod's prior authorization
