A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT BEHALF OF THE CITY GOVERNMENT OF BACOOR, WITH THE DEPARTMENT OF MIGRANT WORKERS REGARDING ESTABLISHMENT OF ITS OFFICE WITHIN THE CITY OF BACOOR.

WHEREAS, on 19 September 2025, the City Mayor, Hon. Strike B. Revilla, formally requested the Sangguniang Panlungsod that a resolution be passed authorizing him to sign and enter into a Memorandum of Agreement (MOA) on behalf of the City Government of Bacoor with the Department of Migrant Workers Regional Office IV-A on proposed establishment of an office within the City of Bacoor.

WHEREAS, the Department of Migrant Workers is mandated to facilitate the overseas employment and reintegration of Filipino workers as well as the promotion of the empowerment and protection of Overseas Filipino Workers (OFWs) and their families through legal assistance and provision of continuous training and development.

WHEREAS, the City Government of Bacoor expresses its willingness to support the Department of Migrant Workers in order to effectively and efficiently deliver accessible government programs and services to Bacooreño OFWs and their families.

WHEREAS, under the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign on its behalf all contracts upon the authority of the Sangguniang Panlungsod. Moreover, no contract may be entered into by the local chief executive without the Sangguniang Panlungsod's prior authorization
