A RESOLUTION APPROVING THE LETTER REQUEST OF JAIRAPEL INTERNATIONAL CORPORATION TO MOVE ITS OPERATIONS TO INNER SUBDIVISIONS AND BARANGAYS IN THE CITY OF BACOR, CAVITE SUBJECT TO CERTAIN CONDITIONS.

WHEREAS, on September 17, 2025, the Office of the City Mayor endorsed a letter from Jairapel International Corporation requesting for the passage of a resolution approving its request to move its dangling wire removal operations to inner subdivisions and barangays in the City of Bacoor, Cavite.

WHEREAS, Jairapel International Corporation is a partner of the city government in removing the so called "spaghetti wires" that endangers public safety which started on August 2025 along the main thoroughfares of Bacoor City.

WHEREAS, a joint committee hearing was held aimed at evaluating the company's request, assess its current accomplishments under the existing Memorandum of Agreement (MOA) with the City Government, and determine the necessary conditions and safeguards should the Sangguniang Panlungsod approve the same.

WHEREAS, during the committee hearing, representatives from Jairapel International Corporation presented updates on its ongoing removal of "spaghetti wires" along the city's major thoroughfares and reported that approximately **25%** of the total cleanup operations had been accomplished to date.

WHEREAS, members of the City Council raised concerns regarding the reported progress and questioned the efficiency and pace of their implementation.

WHEREAS, despite the assurance of the representative of Jairapel International Corporation, **Ms. Ela Radana**, that the said company will undertake measures intended to improve the quality and pace of its operations, the Sangguniang Panlungsod decided to impose certain conditions that the said company must first comply with before it can be allowed to move its dangling wire removal operations to inner subdivisions and barangays in the City of Bacoor, Cavite.

NOW THEREFORE, upon motion of Hon. Manolo S. Galvez Jr., unanimously seconded by all city councilors present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6th Sangguniang Panlungsod in regular session duly assembled to approve the request of Jairapel International Corporation ("Jairapel") to move its dangling wire removal operations to inner subdivisions and barangays in the City of Bacoor, Cavite. **Provided that:** Jairapel **must** comply with the following conditions before this Resolution can take effect:

- 1. Compliance with MOA and Guidelines:** Jairapel shall strictly comply with the provisions of the existing Memorandum of Agreement (MOA) and the Implementing Guidelines that will be issued by the City Government of Bacoor.
- 2. Creation of an Oversight Committee:** The City Government of Bacoor, together with Jairapel, shall establish a Committee to oversee all activities and operations related to the MOA and this City Resolution.
- 3. Submission of Personnel List and Documents:** Jairapel shall furnish the City Government of Bacoor, through the Oversight Committee, the complete list of employees to be deployed under this project, together with the following:
 - o Passport-sized photos of all deployed employees
 - o Clear copies of Jairapel-issued IDs
 - o Copies of Jairapel-issued Job Orders
- 4. Coordination with Barangays and Homeowners' Associations:** Prior to implementation, Jairapel must coordinate with the Oversight Committee, the concerned Barangay, and the respective Homeowners' Association.
- 5. Approval of Routes and Schedules:** The City Engineering Office, in coordination with the Oversight Committee, shall determine and approve the final routes and schedules of operations.
