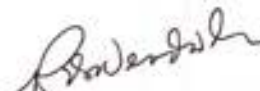

**RESOLVED LASTLY**, to furnish Barangay Salinas 2 and other government agencies concerned with copies of this Resolution.

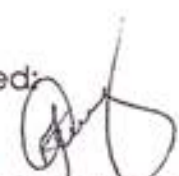
