**A RESOLUTION ADOPTING THE PROPOSED FY 2026 DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) INFRASTRUCTURE PROGRAM FOR CAVITE 3<sup>rd</sup> DISTRICT ENGINEERING OFFICE AND AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE STANDARD RIGHT-OF-WAY CERTIFICATION TEMPLATE FOR LOCAL PROJECTS.**

**WHEREAS**, a joint committee hearing was held on October 23, 2025 regarding the formal request of the City Mayor, Hon. Strike B. Revilla, for the approval by the Sangguniang Panlungsod of a resolution adopting the Fiscal Year 2026 Department of Public Works and Highways (DPWH) infrastructure program for the Cavite 3<sup>rd</sup> District Engineering Office and authorizing him to sign the standard right-of-way certification template for local projects.

**WHEREAS**, pursuant to DPWH Department Order No. 71, Series of 2025, dated April 23, 2025, all local governments that will host projects funded under the Convergence Program (TRIP, ROLL-IT, KATUPARAN, and Farm-to-Market Roads), the Sustainable Infrastructure Projects Alleviating Gaps (SIPAG), and the Basic Infrastructure Programs (BIP) are required to submit a Standard Right-of-Way (ROW) Certification together with a Sangguniang Panlungsod Resolution prior to the awarding of contracts.

**WHEREAS**, the said directive aims to ensure proper coordination between the DPWH and the City Government to resolve legal and administrative issues concerning affected properties ahead of project implementation, and to avoid delays in the execution of infrastructure projects thereby
