Infrastructure Projects of the City of Bacoor, Cavite, For Inclusion in the Regional Development Investment Program (RDIP)",



#### CDC RESOLUTION No. 05 Series of 2025

A RESOLUTION REQUESTING THE CAVITE PROVINCIAL DEVELOPMENT COUNCIL (PDC) TO ENDORSE THE FLOOD CONTROL AND VARIOUS INFRASTRUCTURE PROJECTS OF THE CITY OF BACOOR TO THE CALABARZON REGIONAL DEVELOPMENT COUNCIL (RDC) FOR POSSIBLE FUNDING AMOUNTING TO TWENTY- THREE BILLION TWO HUNDRED NINETY MILLION TWO HUNDRED FORTY-NINE THOUSAND THREE HUNDRED EIGHTY-FOUR PESOS AND TEN CENTAVOS (PhP23,290,249,384.10)

WHEREAS, the climate of the City of Bacoor has two (2) pronounced seasons-the dry season and the wet season-wherein heavy rainfall during the latter causes recurrent flooding in various parts of the city;

WHEREAS, due to its low-lying terrain, rapid urbanization that increases runoff by decreasing ground absorption, and severely clogged and outdated drainage infrastructure that hinders water flow, the City of Baccor is highly vulnerable to flooding, which may affect the lives of the people and damage the properties, livelihood, and economic activities of the City;

WHEREAS, to mitigate the flooding problem and strengthen climate resilience, the City Development Council (CDC) of Bacoor has identified necessary flood mitigation projects that require funding from other government agencies to be implemented:
