Desamito, transmitted the Bacoor Component City Police Station (CCPS) Localized Anti-Criminality Action Plan (LACAP) entitled, "Implementation of Nighttime Transaction Window Policy for Crime Deterrence", to the Office of the City Mayor, Hon. Strike B. Revilla, dated 6 August 2025.

WHEREAS, a copy of the proposed action plan was subsequently endorsed on August 29, 2025 to the Sangguniang Panlungsod for adoption and passage of a city resolution.

WHEREAS, the city government is dedicated to assisting the Philippine National Police in implementing a responsive and comprehensive anti-crime strategy to successfully prevent, control, and reduce crimes in order to maintain a peaceful society in Bacooreños.


