**A RESOLUTION RECOMMENDING TO THE CITY MAYOR, HON. STRIKE B. REVILLA, THE SUSPENSION OF MR. WILLER ALAMO, SK CHAIRPERSON OF BARANGAY BAYANAN, CITY OF BACOR, CAVITE, FOR DISHONESTY AND FOR VIOLATION OF THE RULES OF AN INTER-CLUSTER BASKETBALL TOURNAMENT HELD IN HIS AREA OF JURISDICTION.**

**WHEREAS**, a verified complaint was filed by Ms. Juanise I. Ignacio, Auditor of the Sangguniang Kabataan (SK) Federation of Bacoar City (the "complainant"), against Mr. Willer S. Alamo, SK Chairperson of Barangay Bayanan, Bacoar City (the "respondent") for his alleged dishonesty and for alleged violation of the rules of an inter-cluster basketball tournament conducted at the said barangay.

**WHEREAS**, the said complaint was referred to the Committee on Ethics, Appointments, and Government Reorganization on October 27, 2025. Acting on the said referral, the Committee began its preliminary investigation of the complaint during a hearing on October 30, 2025 at the Session Hall of the Sangguniang Panlungsod. The hearing was presided over by Hon. Miguel N. Bautista, Chairperson of the Committee on Ethics, Appointments and Government Reorganization.

**WHEREAS**, in attendance during the said hearing were the complainant, the respondent, and a representative from the Office of the City Legal Services.

**WHEREAS**, during the said hearing it was discovered that the complainant was in-charge of checking the rosters of the nine teams that will participate in an inter-cluster basketball tournament at Barangay Bayanan to be held sometime on November 2025. Ms. Ignacio also alleged that it was also her duty to check the various credentials submitted by the players of each team as well as to handle any protest to be submitted by the said teams related to the tournament.

**WHEREAS**, the complainant also alleged that the coach of the Cluster 1 Team informed her that players of Cluster 8 Team submitted falsified documents in order to gain undue advantage against the other teams. Upon checking the documents submitted by the various teams, Ms. Ignacio found

out that nine Voter's Certificates were falsified to make it appear that the said players are registered voters of Barangay Bayanan and that the said actions were done under the supervision of Mr. Alamo.

**WHEREAS**, the complainant also discovered, upon confirmation with the Commission on Elections, that the said players were registered voters of other barangays which clearly violated one of the rules of the tournament limiting participation to registered voters of Barangay Bayanan.

**WHEREAS**, the respondent was given a copy of the verified complaint and was given the opportunity to answer the allegations against him.

**WHEREAS**, during the said hearing, the respondent admitted under oath that he spearheaded the submission of the said falsified documents to ensure that the Cluster 8 Team would be stronger than the other teams and eventually win the tournament in clear contravention of Article 171 of the Revised Penal Code defining and penalizing the falsification of public documents by public officials. The elements of the said crime are as follows:

1. The offender is a public officer or employee which includes an SK official such as the respondent.
2. He or she takes advantage of their official position.
3. He or she commits any of the enumerated acts of falsification, such as:

a) Counterfeiting or imitating any handwriting, signature or rubric;

b) Causing it to appear that persons have participated in any act or proceeding when they did not in fact so participate;

c) Attributing to persons who have participated in an act or proceeding statements other than those in fact made by them;

d) Making untruthful statements in a narration of facts;

e) Altering true dates;

f) Making any alteration or intercalation in a genuine document which changes its meaning;

g) Issuing in an authenticated form a document purporting to be a copy of an original document when no such original exists, or including in such a copy a statement contrary to, or different from, that of the genuine original; or

h) Intercalating any instrument or note relative to the issuance thereof in a protocol, registry, or official book.

**WHEREAS**, the evidence gathered during the preliminary investigation provides sufficient grounds to believe that the allegations levelled against the respondent are true and are so
