Series of 2025 A RESOLUTION AUTHORIZING THE CITY MAYOR TO PURSUE LEGAL MEASURES CONCERNING THE UNAUTHORIZED "CITY OF BACOOR

WHEREAS, on 12 November 2025, Mayor Strike B. Revilla formally requested the Sangguniang Panlungsod to pass a Resolution authorizing him to "undertake all appropriate legal, administrative, and cybercrime actions necessary to protect the integrity of the City Government".

WHEREAS, the said request stemmed from the creation of a Facebook group identifying itself as "City of Bacoor 2.0". The said group, according to Mayor Revilla, "is misrepresenting itself as an official communication platform of the City Government of Bacoor, including unauthorized use of the city seal and other official insignia."

WHEREAS, the Honorable City Mayor further alleged that the said Facebook group "poses a serious risk of public misinformation, reputational damage to the City Government, and potential violations of existing laws on cybercrime, falsification, illegal use of symbols, and related offenses."

WHEREAS, among the corporate powers granted under Section 3 of Republic Act No. 10160 (the "Charter of the City of Bacoor") to the City Government is to sue and to be sued.

WHEREAS, Section 8, paragraph (b), sub-paragraph (2) of the RA No. 10160 empowered the City Mayor to "enforce all laws and ordinances relative to the governance of the City and
