**WHEREAS**, the Public Financial Management Assessment Tool (PFMAT) was introduced by the national government designed to assist local government units (LGUs) in evaluating their Public Financial Management Performance and in determining the strength and weaknesses of their respective PFM systems. It serves as basis for the adoption and implementation of improvement measures and provides baseline information on the state of LGU PFM.

**WHEREAS**, the Public Financial Management (PFM) Team of the city government prepared a Public Financial Management Improvement Plan (PFMIP) for implementation for Fiscal Year 2026 up to 2028.

**WHEREAS**, the said plan involves the programs/projects/activities to be implemented by the (1) Office of the City Mayor; (2) City Finance Department (City Treasurer's Office); and by the (3) Office of the Accounting and Internal Audit Services. The proposed Public Financial Management Improvement Plan (PFMIP) is incorporated herein and made an integral part of this Resolution.

**WHEREAS**, on 30 October 2025, the Office of the City Mayor submitted the proposed PFMIP to the Sangguniang Panlungsod for adoption and approval.
