

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF TRANSPORTATION AND THE CITY GOVERNMENT OF BACOOR RELATIVE TO THE TRANSFER OF FUNDS FOR THE IMPLEMENTATION OF THE ACTIVE TRANSPORT PROGRAM.

WHEREAS, on 4 November 2025, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor on behalf of the City Government of Bacoor to sign a Memorandum of Agreement with the Department of Transportation (DOTr) relative to the transfer of funds from the DOTr to the city government for the implementation of the former's "Active Transport Program".

WHEREAS, the DOTr is the primary policy planning, coordinating, implementing administrative entity of the national government in the promotion, development, and regulation of dependable and coordinated network of transportation systems in the country.

WHEREAS, the Active Transport Program is a national initiative of the DOTr aimed at promoting safe, accessible and sustainable means of transportation by developing and improving infrastructure that supports walking, cycling, and other forms of active mobility;

WHEREAS, the DOTr shall provide financial assistance to the City Government of Bacoor for the construction and enhancement of active transport facilities, including but not limited to pedestrian walkways, protected bike lane and other necessary infrastructure improvements,
