WHEREAS, an endorsement letter from the Office of the City Mayor, requesting authority to sign a Contract of Lease between the City Government of Bacoor and the Development Bank of the Philippines, was transmitted to the Office of the Sangguniang Panlungsod on 19 November, 2025.

WHEREAS, the lease premises is owned by the City Government of Bacoor, which covers approximately one hundred sixty-three (163) square meters situated at the ground floor of the Bacoor Legislative and Disaster Resilience Building (BLDRB) located at the Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite.

WHEREAS, the leased premises is for the sole purpose of utilizing it as the DBP Bacoor Branch for office operations, banking activities, and related services.

WHEREAS, a draft Contract of Lease (COL) is made an integral part of this Resolution in order to promote mutual benefit for both institutions, adhere to internal norms, and provide clarity on the terms of usage.

Nolasco, duly seconded by the rest of the Council BE IT RESOLVED AS IT IS HEREBY RESOLVED by the 6<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor, Hon.
