A RESOLUTION AUTHORIZING THE ISSUANCE OF TEMPORARY BUSINESS PERMITS IN FAVOR OF INFORMAL SETTLERS AND PERSONS OPERATING VARIOUS BUSINESSES PARCELS OF LAND WITH DISPUTED OWNERSHIP IN RECOGNITION OF THEIR CONTRIBUTION TO THE LOCAL WITHOUT VALIDATING, SUPPORTING, RECOGNIZING ANY LEGAL CLAIM OR RIGHT ON THE SAID REAL PROPERTIES.

WHEREAS, data provided by the Business Permits and Licensing Department show that there are many small and micro business enterprises owned by informal settlers in the City of Bacoor, Cavite that are operating without a business permit.

WHEREAS, it has also come to the attention of the Sangguniang Panlungsod, through Councilor Reynaldo D. Palabrica, that there are a number of business enterprises in the City of Bacoor, Cavite that cannot obtain a business permit because the ownership of the land on which the said businesses are situated is in dispute.

WHEREAS, the said businesses must be regulated by the City Government by issuing temporary business permits in their favor to make sure that they are operating in accordance with law without, however, validating, supporting, or recognizing any legal claim or right over the real properties whose ownership is in dispute where the said enterprises are situated.

NOW THEREFORE, upon motion of Councilor Reynaldo D. Palabrica, duly seconded by Councilor Manolo S. Galvez Jr, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the 6th Sangguniang Panlungsod in regular session assembled to authorize the issuance of temporary business permits by the Business Permits and Licensing Department in favor of informal settlers and business enterprises in the City of Bacoor, Cavite that cannot obtain a business permit because the ownership of the land on which the said businesses are
