A RESOLUTION AUTHORIZING THE CREATION OF A TECHNICAL WORKING GROUP ON THE FORMULATION OF THE IMPLEMENTING RULES AND REGULATIONS OF CITY ORDINANCE NO. 320-2023 OTHERWISE KNOWN AS THE "2023 BARANGAY BOUNDARIES SETTLEMENT ORDINANCE OF THE CITY OF BACOR, CAVITE".

WHEREAS, City Ordinance No. 320-2023 (otherwise known as the "2023 Barangay Boundaries Settlement Ordinance of the City of Bacoor") was approved by the Sangguniang Panlungsod on 23 October 2023.

WHEREAS, Section 6 of the said ordinance provides that the Office of the City Legal Service, with the assistance of the Zoning and Land Development Department, the City Environment and Natural Resources Office, and the City Engineering Office, shall formulate the implementing rules and regulations of the said legislation.

WHEREAS, since City Ordinance No. 320-2023 took effect, the Sangguniang Panlungsod conducted a series of public hearings attended by the officials and residents of the 47 barangays of the City of Bacoor, Cavite thresh out the various aspects of the settlement of the political boundaries of the said local government units and assist the above-mentioned departments in the formulating the implementing rules and regulations of the said piece of legislation.

WHEREAS, on 7 November 2025, the Sangguniang Panlungsod concluded the said public hearings.

WHEREAS, there is a need to create a Technical Working Group comprised of representatives of the said
