A RESOLUTION RESPECTFULLY RECOMMENDING TO THE CITY MAYOR THE CLOSURE OF SMALL ANGELS BIRTHING CLINIC SITUATED AT LATERO ST., GREEN VALLEY, BARANGAY SAN NICOLAS 3, BACOR CITY, CAVITE DUE TO VIOLATIONS OF VARIOUS LAWS AND CITY ORDINANCES.

WHEREAS, sometime in July 2025, it came to the knowledge of the Sangguniang Panlungsod that the infant child of the spouses Alexis and Irhien Rivera died on 14 July 2025 at Small Angels Birthing Clinic allegedly due to the fault of the owners of the said establishment.

WHEREAS, the Committee on Health and Sanitation of the Sangguniang Panlungsod conducted five (5) committee hearings to determine the truth of the said allegation beginning on 8 August 2025. All of the said hearings were attended by the owners/midwife and employees of Small Angels Birthing Clinic.

WHEREAS, during the course of the said hearings, it was discovered by the said Committee that Small Angels Birthing Clinic was operating without a sanitary permit at the time the said infant died in violation the Health, Sanitation, and Safety Code of the City of Bacoor (City Ordinance No. 55-2015) as amended by City Ordinance No. 253-2022 (otherwise known as the "Infant Safety Code of the City of Bacoor") and Presidential Decree No. 856 (the "Code on Sanitation of the Philippines").

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica, duly seconded by all of the members of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite in
