### CITY RESOLUTION NO. 2025-910 Series of 2025

**A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN SITIO BULATE, BARANGAY DULONG BAYAN AND TO AUTHORIZE CITY MAYOR STRIKE B. REVILLA, CITY DRRM COUNCIL CHAIRPERSON, TO DISBURSE THE AMOUNT OF FOUR MILLION PESOS (P4,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED AS QUICK RESPONSE FUND FOR RELIEF GOODS AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.**

**WHEREAS**, in the evening of 14 December 2025, a fire broke out in a house in Sitio Bulate, Barangay Dulong Bayan, City of Bacoor, Cavite, that rapidly spread to adjacent dwellings that are mostly made from light materials resulting in massive property damage.

**WHEREAS**, in response to the said disaster, the City of Bacoor Disaster Risk Reduction and Management Council (CBDRMC) passed Resolution No. 09, Series of 2025 dated 15 December 2025 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Sitio Bulate, Barangay Dulong Bayan, City of Bacoor, Cavite and authorizing the release of Four Million Pesos (Php 4,000,000.00) from the City Disaster Risk Reduction and Management Fund.

**WHEREAS**, around 120 families were relocated and are presently staying at JS Ville Gym which serves as the evacuation center for those affected by the disaster and where they receive much needed relief and assistance from the City Government.
