REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY-REGIONAL OFFICE 4A ON BEHALF OF THE CITY GOVERNMENT OF BACOR REGARDING THE IMPLEMENTATION OF PROJECT PROPOSAL ENTITLED: "ENHANCING SUSTAINABLE LIVELIHOODS FOR PERSONS DEPRIVED OF LIBERTY (PDLs) BY UPGRADING THE BACOR CITY JAIL MALE DORMITORY BAKERY WITH MODERN EQUIPMENT AND DOST-FNRI NUTRI-COCOKIES AND NUTRIBUNNET TECHNOLOGY ADOPTION".
