DEED OF SALE

KNOW ALL MEN BY THESE PRESENTS:

This *Deed of Sale* ("Deed") is made and entered into by and between:

PRINCESITA R. BAQUIR, of legal age, Filipino, residing and with postal address at Del Pilar Street, Poblacion West, Muñoz, Nueva Ecija (hereinafter referred to as the "SELLER")

and

CITY GOVERNMENT OF BACOOR, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, represented herein by its City Mayor, **HON. STRIKE B. REVILLA**, pursuant to his authority conferred and embodied in City Resolution No. _____ Series of _____ approved _____ of the City Council of Bacoor City, Cavite¹ (hereinafter referred to as the "PURCHASER")

For the purpose of this Deed, each shall be referred to as a "Party" and collectively as the "Parties".

WITNESSETH:

WHEREAS, the SELLER is the beneficial owner of a parcel of land, identified as Lot No. 6685, containing an area of 52,000 square meters, more or less, covered by Tax Declaration No. 19-238-0067-53180² situated in Molino IV, Bacoor City, Cavite ("Subject Property") by virtue of a *Deed of Sale* with The Intestate Estate of Antenor S. Virata³;

WHEREAS, the PURCHASER has offered to purchase from the SELLER a portion of the Subject Property containing an area of 27,492 square meters, more or less, at PHP5,500.00/sqm based on the *Latest Appraisal Report* of the City Assessor's Office,⁴ subject to certain terms and conditions hereinafter set forth;

NOW, THEREFORE, for and in consideration of the foregoing premises, the payment of the purchase price, the SELLER hereby sells, transfers and conveys to the PURCHASER the Subject Property, subject to the following terms and conditions:

1. The Purchase Price shall be PHP5,500.00/sqm, or a total of **PHILIPPINE PESOS: ONE HUNDRED SIXTY MILLION TWO HUNDRED SEVENTY-EIGHT THOUSAND THREE HUNDRED SIXTY AND 00/100 (PHP 160,278,360.00)**, inclusive of relevant taxes such as capital gains tax.

The PURCHASER agrees to shoulder the expenses for the payment of capital gains tax, documentary stamp tax, transfer taxes, notarial fees, and all other fees, charges, penalties (if any), or expenses relative to or as a consequence of the transfer of the tax declaration over the Subject Property in favor of the PURCHASER.
