**A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN SITIO TABING ILOG, BARANGAY MOLINO 4, AND SITIO NEVER LAND, SILANGAN, BARANGAY NIOG OF THE CITY OF BACOOR, CAVITE AND AUTHORIZING THE RELEASE OF FIVE MILLION PESOS (PHP 5,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.**

**WHEREAS**, a fire broke out in a residential unit at Sitio Tabing-Ilog, Barangay Molino 4 in the evening of April 19 2026, that rapidly spread to adjacent residential units which were mostly made from light materials thereby affecting around 37 families whose houses were destroyed.

**WHEREAS**, in the early morning of 22 April 2026, a fire broke out at Sitio Never Land, Silangan, Barangay Niog that rapidly spread to adjacent commercial and residential units affecting 80 families whose houses were also destroyed.

**WHEREAS**, the Bacoor City Disaster Risk Reduction and Management Council (CBDRPMC) passed Resolution No. 06, Series of 2026 dated April 22, 2026, requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Molino 4 and Barangay Niog, City of Bacoor, Cavite and authorizing the release of **Five Million Pesos (Php 5,000,000.00)** from the City Disaster Risk Reduction and Management Fund to be used for financial assistance, relief goods, and other incidental expenses related to relief and rehabilitation operations.

**Resolution No. 06**  
Series of 2026

**"A RESOLUTION REQUESTING THE SANGGUNIANG PANLUNGSOD TO DECLARE THE EXISTENCE OF A STATE OF CALAMITY IN SITIO TABING ILOG, BARANGAY MOLINO 4 AND SITIO NEVERLAND, SILANGAN, BARANGAY NIOG WHICH SUSTAINED MASSIVE PROPERTY DAMAGES WHEN A FIRE INCIDENT BROKE OUT IN THE AREA ON 19 APRIL 2026 AND 22 APRIL 2026, RESPECTIVELY."**

**WHEREAS**, in the evening of 19 April 2026, a fire broke out in a residential unit in Sitio Tabing Ilog, Barangay Molino 4, City of Bacoor, Cavite, that rapidly spread to adjacent residential units which were mostly made from light materials;

**WHEREAS**, in the early morning of 22 April 2026, a fire broke out in a residential unit in Sitio Never Land, Silangan, Barangay Niog, City of Bacoor, Cavite, that rapidly spread to adjacent commercial and residential units which were mostly made from light materials;

**WHEREAS**, initial damage and needs assessment in Sitio Tabing Ilog, Barangay Molino 4 showed that there were around 37 families affected by the fire incident;

**WHEREAS**, initial damage and needs assessment in Sitio Never Land, Silangan, Barangay Niog showed that there were around 80 families affected by the fire incident;

**WHEREAS**, the affected families were relocated and presently staying at Likha Elementary School and Niog Elementary School, respectively;

**WHEREAS**, there is a need to extend immediate assistance to the fire victims i.e., hot meals and dry goods, financial assistance for their temporary shelters;

**NOW, THEREFORE**, on the motion of Ms. Emiliana DR. Ugalde, City Social Welfare and Development Officer, and unanimously seconded by all the members present, **BE IT RESOLVED**, as it is hereby resolved to request the Sangguniang Panlungsod to pass a resolution declaring the existence of a state of calamity in Sitio Tabing Ilog, Barangay Molino 4 and Sitio Never Land, Silangan, Barangay Niog, and to authorize City Mayor Strike B. Revilla, City DRRM Council Chairperson, to disburse the amount of Five Million Pesos (P5,000,000.00) from the Disaster Risk Reduction and Management Fund to be used as quick response fund for relief goods and other incidental expenses related to relief and rehabilitation operations.

**RESOLVED FINALLY**, to furnish the Office of the Sangguniang Panlungsod for appropriate action.
