SECTION 1. Title. This Ordinance shall be known as the "Anti-Open Burning Ordinance of Barangay Salinas 2," considering risk health and safety, because it releases toxic substance and acts as a fire hazard.

SECTION 2. Legal Basis. This ordinance is based on Republic Act No. 9003 (Ecological Solid Waste Management Act of 2000), which prohibits the open burning of solid waste, and the Revised Environment Code of the City of Bacoor (City Ordinance No. 438-2025).

SECTION 3. Prohibited Acts. It shall be unlawful for any person, household, or establishment within the jurisdiction of this Barangay to engage in the open burning of solid waste, including but not limited to:

- o Dry leaves, twigs, and yard waste
- o Plastics, rubber, and other hazardous materials.
- o Household garbage and commercial refuse.

SECTION 4. Fines and Penalties. In accordance with the uniform procedure of the City of Bacoor (City Ordinance No. 228-2022), violators may be issued an **Ordinance Violation Receipt (OVR)**.

- **First Offense:** Fine of P 200.00 or community service (as per city-wide standards for minor environmental violations).
- **Second Offense:** Fine of P300.00.
- **Third Offense:** Fine of P500.00.

SECTION 5. ENFORCEMENT. The Barangay Solid Waste Management Committee and Barangay Tanods are hereby deputized to monitor and report violations to the City Environment Services Department (CESD).

SECTION 6. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval and posting in at least three (3) conspicuous places in the Barangay.




