**WHEREAS**, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to sign a Contract of Affiliation with the National University(NU) MOA, Inc. on behalf of the City Government of Bacoor with regard the affiliation and training of NU Interns in health centers operated by the City Government to conduct the following activities: (1) Community Health Nursing (CHN), and (2) Maternal and Child Health Nursing (MCN) Exposure.

**WHEREAS**, the NU assures that their students shall adhere to the protocols of the barangays where they will serve and maintain the highest level of professionalism and confidentiality in coordination with Barangay Health Workers (BHWs) and with the Office of the City Health Services.

**WHEREAS**, the Office of the City Mayor submitted a copy of a draft Contract of Affiliation between the City Government and the NU MOA Inc. to the Sangguniang Panlungsod for its review and consideration. The proposed agreement is hereby deemed incorporated into and made a part of this Resolution as **Annex "A"**.

**CONTRACT OF AFFILIATION**

**KNOW ALL MEN BY THESE PRESENTS:**

This **CONTRACT OF AFFILIATION** made and entered into the City of Pasay this March 17, 2026 by and between:

The **BACCOOR CITY HEALTH OFFICE** with principal address at Bacoor Blvd., Bacoor City, herein represented by its Mayor, **HON. STRIKE B. REVILLA**, Bacoor herein referred to as the **LOCAL GOVERNMENT UNIT (LGU)**.

And

The **NU MOA, INC.**, an educational institution duly recognized by the Commission on Higher Education with office at Coral Way Drive MOA Complex, Pasay City, Philippines, represented in this Act by **DOLLY ROSE S. MANALANG**, Executive Director, thereof, hereunto duly recognized and hereinafter referred to as the **SCHOOL**.

**WITNESSETH: THAT**

**WHEREAS**, the LGU has tasked its City Health Office to provides training of students in the field of Nursing.

**WHEREAS**, the SCHOOL has requested for affiliation for the training for the students in the field of Nursing, to enable them to know clinical/community health experience and exposure, and the LGU has acceded to the request of the SCHOOL subject to the terms and conditions set forth hereunder:

Now **THEREOF**, for and in consideration of the foregoing premises, the parties hereto have agreed, and bind themselves as follows:

**1. AFFILIATION**

Subject to the terms and conditions set forth herein the LGU and the SCHOOL hereby agrees to the following:

A qualified Faculty / Clinical Instructor of the SCHOOL to attend training and orientation set by the City Health Office.

To conduct a general orientation of nursing students of the SCHOOL to be facilitated by the City Health Office prior to Community Health and Lying-in clinical exposure.

**2. COVENANTS OF THE LGU**

LGU shall allow the student affiliates the use of LGU training facilities for training;

LGU shall determine the number of students and their place of assignment where, in the judgment of the LGU, the student affiliates could be trained effectively.

The LGU may require the student affiliates to wear proper uniforms, sign attendance sheets, accomplishment forms submit reports, and perform such other duties and responsibilities which the LGU may deem necessary for the proper and effective monitoring of the students' attendance, behavior, and performance and in general, for the effective and efficient implementation of the program.

The LGU shall not in any way be responsible and/or liable for any personal injury including death, or damage to property sustained or caused or contributed to by the students' affiliates. The SCHOOL agrees and binds itself to indemnify the LGU for whatever injuries or damages caused or occasioned there to due to fault or negligence or conduct of the SCHOOL'S students arising from or in connection with, the performance of their obligations under this contract.

The LGU can cancel the affiliation privilege of the SCHOOL or its student affiliates who have not complied with the affiliation requirements or have violated rules and regulations set forth by the LGU.

### **3. COVENANTS OF THE SCHOOL**

The SCHOOL shall ensure that the student affiliates carry with them approval from the Commission on Higher Education and recommended by the Board of Nursing Professional Regulation Commission before the Commencement of their Clinical and field practice in the LGU.

The SCHOOL shall design, formulate, and prepare training program in the field of nursing to be used for the training of the student affiliates subject of his contract;

The SCHOOL shall pay or replace with the same kind brand any damage and/or loss of LGU property equipment and supplies due to the fault or negligence on the part of the student affiliates;

The SCHOOL shall ensure that the student affiliates observe and learn about the LGU policies, rules and regulations, and the professional discipline is maintained at all times;

The SCHOOL shall ensure that no students' affiliates will be allowed to report to the health center or Lying-In clinic without the presence of the clinical instructor or training coordinator. A health center physician/nurse may not act as a substitute;

The SCHOOL shall ensure that all health and safety protocols are strictly enforced and that the student affiliates and clinical instructors are properly equipped with the prescribed protected gears for the duration of face-to-face community rotation.

### **4. AFFILIATION FEE**

For and in consideration of the affiliation and training of its students under this Contract the SCHOOL shall pay to the BACOR CITY GOVERNMENT for this Account of BACOR CITY HEALTH OFFICE (Nursing Affiliation), an affiliation fee per student affiliate per month, regardless of the number of days of exposure of students.

#### **Community Experience/Lying-in:**

**TWO HUNDRED PESOS (Php200.00) per Nursing student affiliate.**

No modification, alteration, or amendment of any of the provisions of its contract shall be binding on the parties here to, unless evidenced by written amendment signed by the parties and approved by the proper authorities.

This Contract shall be from **March 2026 to January 2028** PROVIDED that the same may be revoked or terminated within the said period by the LGU upon violation of the terms and conditions stipulated there in and for non-compliance with the require mentor pertinent provisions of existing laws, rules and regulations.
