**A RESOLUTION APPROVING BARANGAY RESOLUTION NO. 010, SERIES OF 2026 ENTITLED: "THE RELOCATION OF THE ASPHALTING ROAD PROJECT FROM BLK. 1 PENTECOSTAL TO QUEEN VICTORIA STREET, AND AUTHORIZING THE REALIGNMENT OF THE 20% DEVELOPMENT FUND AMOUNTING TO ONE MILLION PESOS (PHP1,000,000.00) OF BARANGAY QUEENS ROW EAST, CITY OF BACOOR, CAVITE."**

**WHEREAS**, an asphaltting road project funded under the 20% Development Fund of Barangay Queens Row East in the amount of One Million Pesos (PhP1,000,000.00) was previously programmed for implementation at Block 1 Pentecostal in the said barangay. However, it was later on ascertained that the said location is within the jurisdiction of Barangay Molino 3, and beyond the administrative and territorial authority of Barangay Queens Row East;

**WHEREAS**, during the meeting held on April 17, 2026 at the Session Hall of Barangay Queens Row East, City of Bacoor, the Barangay Development Council (BDC) formally endorsed the realignment of the project site to Queen Victoria Street, a location within the territorial jurisdiction of Barangay Queens Row East;

**WHEREAS**, the proposed relocation and corresponding realignment of funds are necessary to ensure the compliance with applicable laws, rules and regulations governing the utilization of barangay funds, and promote the efficient delivery of basic infrastructure services to the constituents;
