RESOLVED FURTHER, to furnish the complainant, the respondent, and the Department of Interior and Local Government (DILG) with certified true copies of this resolution.



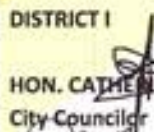


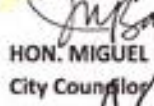
