A RESOLUTION MANDATING THAT ALL TRANSACTIONS, COMMUNICATIONS AND COMPLIANCE REQUIREMENTS OF THE RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC CENTER IN CONNECTION WITH ITS REGISTRATION AS AN ASSESSMENT CENTER SHALL BE CARRIED OUT UNDER THE AUTHORITY OF THE CITY GOVERNMENT OF BACOOR IN RELATION TO CITY RESOLUTION NO. 2026-959 AND TESDA RULES AND GUIDELINES.

WHEREAS, on 02 March 2026, the Sangguniang Panlungsod passed City Resolution No. 2026-959 entitled: "A RESOLUTION AUTHORIZING THE CITY TREASURER TO OPEN A TRUST FUND ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES WHERE FUNDS FROM NATIONAL GOVERNMENT OFFICES AND OTHER CONCERNED AGENCIES INTENDED FOR THE RESOURCES EDUCATION VOCATIONAL INSTRUCTIONAL LIVELIHOOD LEARNING ACADEMIC CENTER WILL BE DEPOSITED TO SUPPORT ITS OPERATIONS, PROGRAMS AND LONG-TERM SUSTAINABILITY AND AUTHORIZING MS. SHIELA MAE GAYAMO AS THE PROCESSING OFFICER OF THE SAID CITY GOVERNMENT FACILITY."

WHEREAS, on 27 April 2026, Ms. Carmelita Gawaran sent a letter to the City Mayor, requesting the Sangguniang Panlungsod to issue a resolution mandating that all transactions of the Resources Education Vocational Instructional Livelihood Learning Academic Center in connection with its registration as an Assessment Center shall be under the authority of the City Government of Bacoor as recommended by the Technical Education and Skills Development Authority (TESDA) following the approval of the aforementioned resolution.

WHEREAS, on 28 April 2026, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution indicating that all transactions, communications and compliance requirement related to the registration of the Resources Education Vocational Instruction Livelihood Learning Academic Center shall be carried out under the City Government of Bacoor in relation to City Resolution No. 2026-959 as well as in compliance with TESDA rules and guidelines.

WHEREAS, on 4 May 2026, the abovementioned matter was referred to the Committee on Rules, Privileges, Laws and Ordinances.
