WHEREAS, in order to clarify the various issues confronting the members of the BCCI and to enable the City Government to effectively address the said concerns, the members of the City Council decided to endorse the suggestions of the members of the said group to the Office of the City Administrator and to the various departments concerned so that the heads of the said offices can meet with members of the business sector and get a clearer picture of what sort of assistance they need from the City Council.
