WHEREAS, the Department of Interior and Local Government (DILG) encourage organization of community Fire emergencies while awaiting the arrival of the Bureau of Fire Protection (BFP).

WHEREAS, the Barangay Talaba 2, recognizes the need for a well trained and organized group of Volunteers, to implement fire prevention programs and provide immediate assistance in the event of conflagration.

SECTION 2. FUNCTIONS AND RESPONSIBILITIES

The CFAG shall perform the following:

- Assist the BFP in conducting fire safety protection inspection and awareness campaigns within the barangay.
- Act as the first responders to suppress small fire and prevent them from spreading.
- Assist in the orderly evacuatio of residents during fire emergencies.
- Maintain a directory and emergency contact numbers and coordinate closely with The Bacoor City Fire Station.
- Ensure that barangay fire- fighting equipment (e.g. fire extinguishers, buckets) are good working condition.

SECTION 3. TRAINING

All members of the CFAG shall undergo training and seminars to be conducted by the Bureau of Fire Protection(BFP), to enhance their skills in fire suppression and rescue Operations.

SECTION 4. EFFECTIVITY

This Resolution shall take effect immediately upon its approval.

UNANIMOUSLY adopted this 19th day of May 2026 , at the Barangay Talaba 2, City of Bacoor , Cavite.


