**A RESOLUTION DISMISSING THE COMPLAINT AGAINST THE SANGGUNIANG KABATAAN OFFICIALS OF BARANGAY HABAY 1, CITY OF BACOOR, CAVITE FILED BY MR. JUN REAGAN VELASCO REQUESTING FOR A REVIEW OF THE SK BUDGET OF THE SAID BARANGAY DUE TO HIS VOLUNTARY WITHDRAWAL OF THE SAID LEGAL ACTION.**

**WHEREAS**, on 8 June 2026, the Office of the Vice Mayor received a copy of a letter signed by Atty. Kevin R. Carpeso, Head Executive Assistant of the Department of Interior and Local Government (DILG) respectfully endorsing for investigation and appropriate action, the 26 May 2026 letter of Mr. Jun Reagan Velasco (the "complainant") requesting for a review of the budget of the budget of the Sangguniang Kabataan Barangay Habay 1, City of Bacoor, Cavite.

**WHEREAS**, the said matter was referred by the City Vice Mayor, Hon. Rowena Bautista-Mendiola, to the Committee on Ethics, Appointments, and Government Reorganization during the 47<sup>th</sup> Regular Session of the Sangguniang Panlungsod on 15 June 2026.

**WHEREAS**, during the 18 June 2026 hearing of the Committee on the various aspects of the said complaint and the various pieces of evidence provided by the parties in a complaint filed by Mr. Velasco against some officials of the Sangguniang Kabataan of Barangay Habay 1, Hon. Miguel Bautista, the Ethics Committee Chairperson, informed the rest of the Committee that the complainant filed a duly notarized Affidavit of Desistance which stated that he is no longer interested in pursuing the case because he is not willing to spend more time and effort to prosecute the case due to the schedule and nature of his work. He also mentioned in the said affidavit that he will just attend the Katipunan ng Kabataan Assembly and ventilate his concerns regarding the utilization of the SK budget of the said barangay in the said event.
