A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE DEPARTMENT OF HEALTH- CENTER FOR HEALTH DEVELOPMENT CALABARZON FOR THE HEALTH FACILITY ENHANCEMENT PROGRAM.

WHEREAS, the national government appropriated Twenty-Two Billion Two Hundred Twenty-Eight Million Nine Hundred Eighty-Two Thousand Pesos (**Php22,228,982,000.00**) for Health Facilities Enhancement Program (HFEP) under Republic Act No. 12314 or the "General Appropriations Act for Fiscal Year 2026" to fund the construction, upgrading, rehabilitation and expansion of government health facilities as well as the procurement of medical equipment and transport vehicles.

WHEREAS, the HFEP serves as the national government's tool from which public healthcare facilities receives assistance for infrastructure improvement and equipment upgrade;

WHEREAS, the DOH through the Health Facilities Enhancement Program for CY 2026 has appropriated the amount of **Nineteen Million Eight Hundred Thousand Pesos (Php19,800,000.00)** intended for the following projects to be implemented and procured by the City Government of Bacoor thru transfer of funds:
