A RESOLUTION APPROVING AND ADOPTING THE PERMANENT SITE FOR THE INSTALLATION OF THE MONUMENT OF GENERAL EMILIO AGUINALDO AT THE INTERSECTION OF AGUINALDO HIGHWAY AND BACOOR BOULEVARD, BARANGAY NIOG, CITY OF BACOOR, CAVITE AUTHORIZING THE IMPLEMENTATION THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, Article II, Section 17 of the 1987 Constitution of the Republic of the Philippines declares that the State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, Article XIV, Section 15 and 16 of the 1987 Constitution recognize the State's duty to conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, otherwise referred to as the General Welfare Clause, authorizes every local government unit to exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those essential to the promotion of the general welfare, including the preservation and enrichment of culture and historical heritage;

WHEREAS, Section 458(a)(1)(vi) of the Local Government Code empowers the Sangguniang Panlungsod

WHEREAS, Section 458(a)(5) of the Local Government Code further authorizes the Sangguniang Panlungsod to approve ordinances and resolutions that promote the efficient administration of the city and the proper use, management, and development of the public properties and infrastructure;

WHEREAS, the City Government of Bacoor recognizes the invaluable contribution of **General Emilio Aguinaldo**, the first President of the Republic of the Philippines, to the nation's struggle for independence and acknowledges his enduring historical significance to the Province of Cavite and the Filipino people;

WHEREAS, the erection of a monument honoring General Emilio Aguinaldo is intended to preserve historical memory, inspire patriotism among present and future generations, promote historical awareness, and establish a civic landmark that reflects the identity and heritage of the City of Bacoor;

WHEREAS, the City Engineering Office, City Planning and Development Office, Office of the Building Official, Traffic Management Department, and other concerned offices conducted technical assessments and determined that the traffic island situated at the intersection of Aguinaldo Highway and Bacoor Boulevard, Barangay Niog, possesses the necessary spatial, structural, engineering, traffic, and aesthetic characteristics suitable for the installation of the monument;

WHEREAS, the proposed site has been evaluated in consideration of the following factors:

1. visibility and prominence as one the principal gateways to the City of Bacoor;
2. compatibility with existing and future road infrastructure;
3. pedestrian and vehicular safety;
4. traffic circulation and operational efficiency;

6. structural stability and engineering feasibility;
7. preservation of road right-of-way and public convenience; and
8. enhancement of the City's historical and cultural identity.

WHEREAS, the approval of the final site by the Sangguniang Panlungsod is necessary to formally establish the official and permanent location of the monument and to authorize the concerned city offices to proceed with its implementation in accordance with existing laws, engineering standards, and government regulations;

NOW, THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED by the Sangguniang Panlungsod of the City of Bacoor, duly assembled in session, to declare and approve the traffic island located at the intersection of Aguinaldo Highway and Bacoor Boulevard, Barangay Nlog, City of Bacoor as the official permanent site for the installation of the Monument of General Emilio Aguinaldo.

RESOLVED FURTHER, that the City Engineering Office shall prepare and implement the final engineering plans, structural designs, construction program, and project supervision necessary for the installation of the monument, ensuring full compliance with applicable engineering codes, structural standards, accessibility requirements, and public safety regulations.

RESOLVED FURTHER, that the City Planning and Development Coordinating Office shall ensure that the monument and its surrounding landscape are consistent with the City's Comprehensive Land Use Plan (CLUP), zoning regulations, urban design principles, and long-term development framework.

RESOLVED FURTHER, that the Office of the City Building Official shall process and issue the necessary permits and clearances, subject to compliance with applicable national laws, local ordinances, and the National Building Code of the Philippines and its Implementing Rules and Regulations.

RESOLVED FURTHER, that the Traffic Management Department, in accordance with the City Engineering Office and other concerned agencies, shall formulate and implement the necessary traffic management measures before, during, and after the installation of the monument to ensure the uninterrupted and safe movement of pedestrians and motorist.

RESOLVED FURTHER, that the City Environment Service Department shall supervise the landscaping, planting, environmental enhancement, and maintenance of the surrounding open space to preserve the monument's dignity and improve the visual character of the area;

RESOLVED FURTHER, that should road widening, infrastructure improvements, national government projects, or public safety requirements necessitate modifications to the monument's immediate surroundings, the City Government shall ensure that the monument's historical integrity, prominence, and commemorative purpose are preserved to the greatest extent practicable;

RESOLVED FURTHER, that the City Mayor is hereby requested and authorized to coordinate with the appropriate national government agencies, including the Department of Public Works and Highways (DPWH), the National Historical Commission of the Philippines (NHCP), and other concerned agencies, whenever required, for the implementation of this Resolution.

RESOLVED FINALLY, that the certified copies of this Resolution be furnished to the Office of the City Mayor, City Engineering Office, City Planning and Development Coordinating Office, Office of the City Building Official, Bacoor Traffic Management Department, City Environment Service Department, Department of Public Works and Highways (DPWH), National Historical Commission of the Philippines, and all other concerned offices for their information, guidance, and appropriate action.
