RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH EAST AVENUE MEDICAL CENTER PERTAINING TO THE ESTABLISHMENT OF A SYSTEM REFERRAL OF PATIENTS DIAGNOSED WITH END-STAGE RENAL DISEASES.

WHEREAS, on 15 June 2026, the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting the City Council to pass a resolution authorizing City Mayor Strike B. Revilla to sign a Memorandum of Agreement (MOA) with East Avenue Medical Center (EAMC) on behalf of the City Government of Bacoor. The proposed MOA is incorporated and made a part of this Resolution as **Annex "A"**.

WHEREAS, the Office of the City Health Services of the City Government of Bacoor regularly encounters patients diagnosed with terminal diseases and End-Stage Renal Diseases (ESRD) who require advanced medical interventions beyond the capabilities of local health facilities.

WHEREAS, the EAMC is a government-owned tertiary medical institution equipped with competent healthcare professionals, specialized medical facilities and treatment programs capable of providing comprehensive and management for patients suffering from terminal illnesses and ESRD.

WHEREAS, the City Government of Bacoor and the EAC mutually agreed that there is a need to establish a referral system that will facilitate timely access to specialized medical services for indigent patients while maximizing available government healthcare assistance programs including

PHILHEALTH benefits and other financial assistance mechanisms.

WHEREAS, under the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign on its behalf all contracts upon the authority of the Sangguniang Panlungsod. Moreover, no contract may be entered into by the local chief executive without the Sangguniang Panlungsod's prior authorization.

NOW THEREFORE, upon motion of Hon. Manolo S. Galvez, Jr., unanimously seconded by the rest of the Body in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor, Hon. Strike B. Revilla, to sign the proposed MOA between the City Government of Bacoor and East Avenue Medical Center pertaining to the establishment of a system for referral of patients diagnosed with End-Stage Renal Diseases.
