WHEREAS, the proposed resolution granting authority to the City Mayor, Hon. Strike B. Revilla, to execute a Memorandum of Agreement on behalf of the City Government of Bacoor was duly referred to the Committee on Health and Sanitation.

WHEREAS, during the Joint Committee Hearing conducted on July 2, 2026, it was clarified that the proposed partnership between the City Government of Bacoor and Vision Check Optical Clinic involves the provision of specialized optometric services, including those covered under the PhilHealth Optometry Benefit Package, within the framework of the PhilHealth YAKAP (Yaman ng Kalusugan Program). The said partnership seeks to enhance the delivery of health services to the constituents of Bacoor City by ensuring access to quality optometric care in accordance with established national health standards.

WHEREAS, the draft Memorandum of Agreement, endorsed by the Office of the City Mayor on June 17, 2026, had undergone prior review by the Office of the City Legal Services, which affirmed its legal sufficiency and conformity with existing laws, and is hereby incorporated as an integral part of this resolution as **Annex "A"**.
