A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOOR AND DE LA SALLE MEDICAL AND HEALTH SCIENCES INSTITUTE REGARDING THE PROPOSED MOBILE BLOOD DONATION ACTIVITY PARTNERSHIP.

WHEREAS, on 22 June 2026, the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting the City Council to pass a resolution authorizing City Mayor Strike B. Revilla to sign a Memorandum of Agreement (MOA) with De La Salle Medical and Health Sciences Institute (DLSMHSI) on behalf of the City Government of Bacoor. The proposed MOA is incorporated and made a part of this Resolution as **Annex "A"**.

WHEREAS, the DLSMHSI – Blood Bank is committed to ensuring the adequacy, safety, and sustainability of the blood supply through the conduct of voluntary non-remunerated blood donation activities.

WHEREAS, the City Government of Bacoor seeks to advance community health initiatives by actively promoting and facilitating voluntary blood donation among its constituents.

WHEREAS, under the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign on its behalf all contracts upon the authority of the Sangguniang Panlungsod. Moreover, no contract may be entered into by the local chief executive without the Sangguniang Panlungsod's prior authorization.
