"AN ORDINANCE PROHIBITING LITTERING, ILLEGAL DUMPING OF WASTE AND OPEN BURNING (PAGSISILAB) WITHIN THE TERRITORIAL JURIDICTION OF BARANGAY TALABA 2, CITY OF BACOR, PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF AND INSTITUTING ENFORCEMENT MECHANISMS."

WHEREAS, Republic Act No. 9003 otherwise known as the Ecological Solid Waste Management Act of 2000, mandate Local Government Unit, particularly barangays, to take primary responsibility for Solid Waste Segregation and Management;

WHEREAS, Republic Act No. 8749 or the Philippine Clean Air Act of 1999, strictly prohibits the incineration and open burning of municipal, bio medical and hazardous waste;

WHEREAS, indiscriminate littering, illegal dumping of garbage and the practice of open burning, degrade the local environment, clog waterways, cause flooding and pose severe respiratory health risks to residents.

WHEREAS, Sangguniang Barangay of Talaba 2, recognize its responsibility to maintain a clean, safe and healthy environment for all its constituents;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Barangay in Session assembled, that :

SECTION 1. TITLE

This Ordinance shall be known as the "Barangay Talaba 2 Clean Air and Clean Environment Ordinance 2026 "

SECTION 2. DEFINITION OF TERMS.

***LITTERING**- the act of throwing , dumping or leaving small amounts of waste matter (such as wrappers, cigarette butts, plastic bottles ,paper) in public places, streets, Sidewalks, waterways.

***ILLEGAL DUMPING** - the bulk disposal or discarding of waste, garbage, construction debris or large items in unauthorized public or private locations.

***OPEN BURNING** -(Pagsisilab)the burning of any materials (such as dry leaves, twigs, plastics, yard waste or garbage) in on open fire or outdoor pit where smoke is released directly into the ambient air (hangin nalalanghap) without passing through stack or chimney.

SECTION 3 PROHIBITED ACTS.

It shall be unlawful for any person , residential household or commercial establishment within the jurisdiction of Barangay to:

1. Litter or discard any form of waste on public roads, sidewalks, parks, drainage systems, creeks, and other public places.

2. Engage in the illegal dumping of household , commercial or institutional waste in vacant lots, waterways, roadside areas.

3. Conduct open burning (pagisilab) of any waste materials, including yard waste (leaves, twigs, plastics, rubber or general household garbage on any time of day.

SECTION 4. DUTIES AND RESPONSIBILITIES

A. OF RESIDENTS/ HOUSEHOLDS

1. Properly Segregate their solid waste into biodegradable, non biodegradable , recyclables and residuals and special wastes.

2. Ensure the garbage is placed inside appropriate containers and brought out for collection only during schedule specified by the barangay or the City Waste Management Unit.

3. Maintain n the cleanliness of their immediate premises , including sidewalk and street fronting their residence up to the center line of the street.

B. OF COMMERCIAL/ INSTITUTIONAL ESTABLISHMENTS

1 .Provide adequate and clearly marked segregated waste bins for customers and employees within their premises.

2. Ensure that their garbage is properly stored, segregated , and collected according to barangay schedule 7: p.m to 8:00 pm.

3. Clean and maintain the cleanliness of the sidewalks and surrounding areas within a three (3) meter radius of their establishment.

SECTION 5. IMPLEMENTING ARM AND ENFORCEMENT

1. The enforcement of this Ordinance shall be the primary responsibility of the Punong Barangay , Barangay Kagawads and the Barangay Tanods

2. The barangay and the CESD shall deputize members of the Barangay Health Committee and other concerned citizens upon issuance of an official identification card, to apprehend violators.

3. Any deputized officers or official who witnesses a violation shall immediately issue a notice of violation detailing the offense committed.

SECTION 6. PENALTIES

Any person found violating the provisions of this Ordinance shall be penalized as follows:

OFFENSE	FINE/ PENALTY
1. First offense	A fine of Php 300.00 and /or 3 hours of community service e.g. streetsweeping
2. Second Offense	A fine of Php 500.00 and/ or community Service mandatory 6 hours.
3. Third Offense	A fine of Php 1,000.00

For Commercial /Business Establishment violating this Ordinance, the Barangay may recommend the suspension or Non Renewal of their Barangay Clearance to the City Licensing Office.

SECTION 7. COLLECTION AND UTILIZATION OF FINES

All fines and fees collected from violations of this Ordinance shall be properly receipted by the Barangay Treasurer. The funds collected shall be primarily used to the Barangay Solid Waste Management Programs, Environmental Projects and Awareness campaigns.

SECTION 8. SEPARABILITY CLAUSE.

If any provision of this Ordinance is declared invalid or unconstitutional in the remaining provisions not affected thereby shall continue to be in full force and effect.

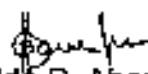
SECTION 9. REPEALING CLAUSE.

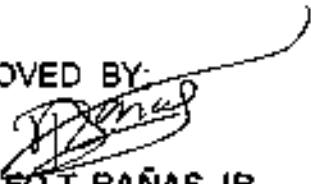
All previous Barangay Ordinances/ Resolutions or parts thereof inconsistent with this Ordinance are hereby repealed or modified accordingly.

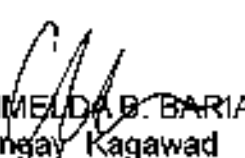
SECTION 10. EFFECTIVITY.

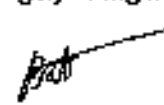
This Ordinance shall take effect immediately upon its approval and compliance with the posting in at least three (3) conspicuous places within the barangay.

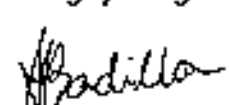
